OFFICE ORDER

Ishrat Zahan Anka, Assistant Professor, Department of Aquaculture, Faculty of Fisheries, Chattogram Veterinary and Animal Sciences University (CVASU), Chattogram, Bangladesh has been granted study leave (1st time) on full average pay initially for 1(one) year with effect from 19/02/2021 to 18/02/2022 to attend the Ph.D course in the Swansea University, UK as per running/revised Leave Rules 2013 (approved by 43rd Syndicate dated 06/07/2019) of this University under the following terms and conditions:

Terms and conditions:

- (1) She will draw her pay and allowance as per leave rules.
- (2) She will not get any salary in foreign currency.
- (3) She will not be allowed to stay abroad more than the permitted period.
- (4) She is required to send her academic progress report through her supervisor after every semester/year.
- (5) This granted leave may be extended subsequently on the basis of her academic progress report as per existing/Revised leave rules.
- (6) She cannot change her registration/university/course of study without prior permission from this university authority.
- (7) She will have to submit a report within seven days after returning from UK.
- (8) She is required to send her overseas contact address including e-mail & telephone number.
- (9) There is no financial involvement of this University and Government of Bangladesh for her journey/Ph.D course and all cost will be borne by the authority of Swansea University, UK or herself.
- (10) If there is further amendment in the present clause 30 of Leave Rules 2013 (Amended) it will be applicable for her.
