RULES RELATING TO THE STUDENTS' DISCIPLINE

[Effective from 15 June 2010]

A. RULES REGARDING GENERAL DISCIPLINE

[As per provision of the Article 4(dha) of the Act of CVASU]

1. According to the provision laid down in Article 32 of the Chattogram Veterinary and Animal Sciences University (CVASU) Act, there shall be a Students; Discipline Committee to supervise and control the residence and discipline of the students of the University.

The Committee shall consist of the following members:

(i)	The Vice-Chancellor	Chairman
(ii)	Deans of the faculty	Members
(iii)	Two Professors to be nominated by the Academic Council	Members
(iv)	Provosts of the halls	Members
(v)	One Member of the Syndicate not receiving salary from	Member
	University, to be nominated by the Syndicate	
(vi)	The Director of Students' Welfare (DSW)	Member
(vii)	The Proctor	Member-Secretary

- 2. The Chairman shall convene the meeting of the Committee as and when required and fifty percent of the members shall form a quorum. The term of nominated members shall be two years, but shall continue till successors are nominated.
- 3. Member of the Committee other than the ex-officio members shall ordinarily hold office to be members for 2 years are nominated.
- 4. (a) All incidents which appear to be acts of indiscipline and misconduct committed by any student including immediate action taken, if any, shall be reported to the Vice-Chancellor by the Provosts through the Proctor in respect to indiscipline and misconduct in the Halls of Residence and their premises; and by the Head/Directors of Departments/Institutes in respect of indiscipline and misconduct in class rooms, laboratories, workshops, library, farms, transport, food processing plant, Teaching Veterinary Hospitals (TVH), Physical health education section, institutes and all parts of the Academic premises, by the

invigilator(s) through the Chief Invigilator in respect of indiscipline and misconduct in the examination halls/rooms; and by the person concerned from among the students, teachers, officers and employees of the University in respect of misconduct committed outside the Halls but within the campus or outside the University.

- (b) All acts of indiscipline/ misconduct, whether reported verbally or in written form or even heard by any authority, as mentioned in article 4 (a) of this rule shall be taken into due consideration and shall be settled by the respective authority within a maximum period of 3 (three) weeks. All authorities except the first three as described in column 1 of 5(b)(Students' Discipline Committee, Vice-Chancellor and Proctor) shall take immediate action against acts of indiscipline/misconduct within their respective jurisdiction after proper verification. All such individual or minor cases/incidence(s) shall be reported to the Proctor for proper recording as well as for reporting to the Students' Discipline Committee.
- 5. (a) A student or group of students who neglects his/her/their studies, disobeys and/or denounces orders, regulations, statutes, rules and Acts of the University, shows misbehavior/inappropriate conduct towards the members of the staff or officers or teachers or outsiders or students of CVASU or commits any other offences(e.g. physical assault to the members of the staff or officers or teachers or outsiders or students of CVASU of the University) which will be deemed by the Vice-Chancellor or Proctor or Teachers of the University as misconduct and breach of discipline, will be liable to disciplinary action which may range from warning, imposition of fines, suspension to expulsion for good from the University, cancellation of awarded degree by CVASU depending on the magnitude of the offence as will be deemed fit by the authorities competent to take disciplinary action as defined in 5(b).
 - (b) Authorities on the magnitude of the offence as will be deemed fit by the authorities competent to take disciplinary action with their respective powers to the extent to which they can impose punishment on any student or group of students are:

- 6. If the Vice-Chancellor feels that the action taken against a student or a group of student by any of the authorities mentioned in 5(b) other than Students' Discipline Committee on an offence brought to him is not appropriate or that no action has been taken on any offence observed by him/her, he/she will take appropriate disciplinary action against a student or a group of students. If, however, in any case of breach of discipline the Vice-Chancellor is of the opinion that a punishment more than a suspension of one year may be required, he/she shall refer the matter to the Students' Discipline Committee for a decision.
- 7. A student or a group of students against whom an action has been taken by appropriate authority mentioned in Colum 1 of Section 5(b) may prefer an appeal to the appropriate appellate authority mentioned in column 3 of Section 5(b). The appeal shall have to be lodged within 15 days of the imposition of disciplinary action.
- 8. The Proctor will be responsible for enforcement of the disciplinary action taken against a student or a group of students. He/she shall maintain a register and shall record in all character certificates issued by the Proctor to offenders, those actions taken against them if so, indicated by the Vice-Chancellor and the Students, Discipline Committee unless allowed to be expunged/condoned by the Syndicate on written prayer from the offenders.
- 9. The Proctor shall not record the punishment like warning, undertaking of the student and/or the guardian imposed by any authority. The monetary fines imposed by any

- authority except Students Discipline Committee shall not be recorded in the character certificate of the offended student(s).
- 10. In an emergency, the Proctor may request any teacher, officer & employee of the University to help him in the discharge of his duties in the University or outside at all hours and it shall be the duty of the teachers, officers or employees concerned to give him/her every reasonable assistance.
- 11. No student or students of the University shall declare a strike at the University nor shall a student interfere with the free movement of the University students willing to attend classes, laboratories, library, TVH and field work etc.; nor shall students organize and/or stage any demonstration in any part of the University campus or its neighborhood without the permission of Proctor.
 - A student or a group of students found guilty of violation of the provisions of this Section will be liable to disciplinary action including expulsion from the University. Students absenting themselves from the classes on the days of strike will lose their percentage of attendance and will be liable to forfeiture of their scholarships and stipends and to other disciplinary actions as the authorities may think fit.
- 12. The Vice-Chancellor at any time may stop temporarily or permanently publication of any journal or magazine or any printed or cyclostyled matter or website(s) which he thinks detrimental to the general interest of the University.
- 13. A student who willfully destroys or damages or defaces University property shall be called upon to make good the loss to the University and will also be liable to other penalties, such as fines and forfeiture of caution money and other disciplinary actions as the authorities may think fit.
- 14. Any student found (by any of the Teachers, Provosts, Proctor or Vice-Chancellor) guilty of misconduct towards any person within the University campus shall be subject to appropriate disciplinary action ranging from fine to expulsion for good from the University as may be decided by the appropriate authority of the University mentioned in the above section.
- 15. Any student found by the Students' Discipline Committee guilty of moral turpitude shall ordinarily be expelled from the University for good. The Academic Council on appeal from the delinquent student may show mercy to deserving cases by imposing less severe punishment.
- 16. The University authority shall have the right to take disciplinary action against any student for any act considered as unethical and/or social crime in the eyes of law of the country. If any student is expelled for good from the university, he/she shall not be eligible for any job of this university in future.

- 17. If any student or group of students found guilty for ragging to any student or group of students, will be liable to disciplinary action ranging from penalty of any amount of money to suspension and expulsion from the University for any length.
- 18. If any student or group of students found guilty for the crime of sexual harassment and or eve-teasing will be liable to disciplinary action of suspension and expulsion from university for any length of duration including for good.
- 19. If any student or group of students found guilty for taking, carrying, preserving supplying and marketing of drugs (narcotics/ intoxicants) will be liable to disciplinary action ranging from penalty of any amount of money to suspension and expulsion from the university for any length of time.
- 20. If any student or group of students found guilty for bulling or cyber-crime(s) or ICT crime and or cyber bulling will be liable to disciplinary action ranging from penalty of any amount of money to suspension and expulsion from the university for any length of time.
- 21. If any student or group of students found guilty for propaganda or campaign against the liberation war, Father of the Nation, National Anthem, National Flag of Bangladesh or any other anti-state activities or terrorist activities or involving with banned organization by the Government of People's Republic of Bangladesh will be liable to disciplinary action of suspension and expulsion from university for any length of duration including for good.
- 22. If any student or group of students found guilty for any kind of fraud in admission test or procedure will be liable to disciplinary action of cancellation of admission from the university and necessary action will be taken as per the law of People's Republic of Bangladesh. In case of graduate and/or postgraduate students the University authority shall have the right to cancel his/her awarded degree.
- 23. Duration of suspension and/or expulsion from the university by this rule will not be considered as regular academic year.

B. RULES REGARDING RESIDENCE OF STUDENTS

[As per provision of the Article 4(Ja) of the Act of CVASU]

PART-I

Rules applicable to resident Male Students

- 1. Resident students must be in their Hall/ Dormitory before 10 P.M. during the months of November to February and 11 P.M. during the rest of the year and must not leave them before 5 A.M. except with the permission of the Provost or Assistant Provost.
- 2. The gate of each Hall/Dormitory shall be closed at 12 P.M. during the months of November to February and at 11-30 P.M. during the rest of the year and it shall not be opened until 5 A.M. next morning except with the permission of the Provost or Assistant Provost.
- 3. A gate-book in which are recorded the times at which students knock in after the gate has been closed must be maintained by the security guard subject to the permission of responsible Assistant Provost of Halls.
 - Students who return after the gate has been closed shall enter in the gate-book their names, time of return and place where they had been.
- 4. The Provost/ House Tutor may visit the Hall/ Dormitory and time without prior notice to ensure the presence of all resident students or to check any unauthorized person(s) inside the hall. All unauthorized person(s) shall be handed over the law enforcement agencies with necessary approval of the proctor.
- 5. A student who willfully destroys or damages University property shall be called upon to make good the loss to the University and will also be liable to other penalties.
- 6. Resident students must return to the Hall on the opening day of each University term and must not be absent from the Hall during term time except when on leave, granted by the Provost. Every application for leave or for extension of leave must reach the House Tutor at least one day before the date of availing the leave or at least one day before the expiry of the original leave. Every application for extension of leave on medical grounds must be accompanied by a Certificate from a recognized medical practitioner and by a letter from the student's guardian.
- 7. Students shall not be permitted to change their rooms without the permission of the Provost or Assistant Provost. Application for change of rooms should be made to the Provost or Assistant Provost.
- 8. Food can be obtained for guests by purchasing guest coupon on payment.

- 9. Students will take their meals in the common Dining Hall at the hours fixed by the Provost. The Provost will fix the hours for meals and will, through the House Tutors, make such other Rules for the good management of Dining Hall as he deems conducive to its interest. Food can be served in students' rooms only on medical grounds and at the discretion of the House Tutor.
- 10. No private servants may be employed by students. No servants may be appointed in any department of the Hall without the sanction of the Provost. The Provost shall have the right to dismiss any servant employed in the Hall.
- 11. Any case of assault on a Hall staff will be punished.
- 12. Cycling and playing in the corridors of the Halls is prohibited.
- 13. Students are expected to keep their rooms clean and in good order.
- 14. (i) Hall Dinning shall be run according to the rules set by the Dinning Committee of respective Hall.
 - (ii)The Dinning Committee Shall be formed with two representatives of each session for one year. The representative shall be nominated among the students of respective academic session. The Provost will be the Convener of the Dinning Committee and one of the Assistant Provosts will be the Member Secretary.
 - (iii) Provost has the right to change or modify this committee if necessary.
- 15. All students are expected to take part in some form of out-door exercise.
- 16. All applications, representations or complaints must be signed and addressed to the Provost and submitted through the House Tutor who shall forward them to the Provost with his recommendation thereon.
- 17. Any notice concerning students shall be published on the Hall Notice Board and shall be considered as having been brought to the notice of students, both resident and attached. Failure to read a notice will not be accepted as an excuse for noncompliance with such notice. Removing, tearing and tempering of hanged notice by the authority shall be considered as a serious allegation and be punished with expulsion from the Hall or a fine up to Tk. 5000 (Taka Five thousand).
 - No notice shall be placed on the Notice Board of a Hall without the permission of the Provost.
- 18. No clubs or societies shall be formed and no meetings shall be held within the Hall premises without the previous permission of the Provost.
- 19. No student shall give a party or entertainment in the Hall without the previous permission of the Provost, nor shall he play any musical instrument with high volume or use a loud speaker without the permission of the Provost.

- 20. (a) Inter-Hall meetings and function can only be held with the express previous permission of all the Provosts concerned.
 - (b) Nobody should be allowed to participate in these functions who is not a bona fide resident or attached student of the University or a teacher of the University.
- 21. In all Hall meetings or function the Provost shall have the right to approve of the programmes and lay down the conditions under which they shall be held. The Programmes of all Inter-Hall meetings, functions etc. shall be approved by all the Provosts concerned.
- 22. Nothing shall be published related to the hall in any Hall Magazine or Journal or any social media (Facebook, online news portal, twitter, what's app etc.) without the approval of the Provost. In such offense the provost shall have the power of expulsion from the hall up to one (1) year from the date of the order.
- 23. In no University of Inter-Hall function, as distinct from a Hall function, shall any object or symbol or recitation or song be allowed which is likely to damage the religious or political feelings of any community.
- 24. The Provost of a Hall shall have power to report the Controller of Examinations to withhold the result of an office-bearer of his Hall Union, who has not rendered proper account of the Union money drawn by him. Similar action may be taken by the Provost of the relevant Hall in the case of an office-bearer of the CVASU Central Students' Union (CCSU), who has not rendered proper account of the University money drawn by him, on a report from the Treasurer, (CCSU).
- 25. The Provost is entirely responsible for drawing and disbursing any University money which is allotted to meet the expenses of different sections of his Hall and shall lay down such Rules as may seem to him necessary for the proper expenditure of such money.
- 26. Provost shall have power to frame Rules for the use of the Libraries/ BCS Preparatory Club attached to the respective Halls.
- 27. The Provost will issue a NOC to Controller of Examinations indicating all the fees and liabilities by the student are met. Without this NOC he will not be provided with the final exams Certificate/ Provisional Certificate/ Testimonial.
- 28. Students committing serious offences, such as absence without leave from the Hall, holding any meeting in the Hall without the approval of the Provost and introduction of any person unauthorized by the Provost into the Hall, will be subject to disciplinary action which involve expulsion from the Hall.
- 29. Candidates at University Examinations shall, within three days after the completion of their Examinations, clear up all dues to their Halls and return all books to the University Library.

- 30. Any breach of rules and regulation assigned by the Hall authority during admission of a new student will be considered as an offence and the Provost or House Tutor shall have the power to take disciplinary action his jurisdiction.
- 31. The Syndicate shall, on receipt of reports from the Provost concerned, withhold the publication of the results of candidates who do not comply with this Section.
- 32. (a) The results of a student who is appearing of has appeared at any of the Examination conducted by the CVASU may be withheld for any of the following reasons:
 - (i) If the student in question has liability to the University;
 - (ii) If disciplinary proceedings are pending against him/her.
 - (b) For misconduct or any act prejudicial to discipline the authority may withhold the result.
- 33. The Provost shall have power to impose on a student a fine up to Tk. 5000 (Taka five thousand) and or expulsion from the hall up to one year at a time for a breach of discipline or misconduct in Hall/dormitory premises. If he is of opinion that a fine of Tk. 5000 is not sufficient, he/she shall have power to expel a student from the University for a period not exceeding one year to be counted from the date of order. If, however, he is of opinion that the case requires expulsion for more than one year he shall refer the case to the Vice-Chancellor/ Students' Discipline Committee for such action as he may deem fit.
- 34. Supplying, keeping, carrying, selling and addiction of drugs will be considered as serious offence and the offender student will be suspended temporary by the provost until the final decision received from the hall authority.
- 35. Ragging or any kind of physical or mental harassment will be considered as a serious offence and the offender student/students will be suspended temporary by the provost until the final decision received from the hall authority.
- 36. Student must have to leave hall within 7 (seven) days after publication of his final result (Hon's/Master's). Provisional/original certificate will be provided after cancellation of seat in Hall.

PART-II

Rules applicable to resident Female Students

- 1. Female students shall be attached to or resident in the Female's Hall. They shall also be subject to Sections 4-36 of Part-I of this Chapter.
- 2. Resident Female students shall not be away from the Hall in between 9 p.m. and 7 a.m. without the written permission of the Provost to be recorded in a book kept for the purpose. Except for attending classes in the University, verbal permission of the Provost must be obtained for leaving the Hall at other times.
- 3. (i) After Closing of the Hall gate, if a student needs to stay outside the Hall, then that student will be allowed to enter the Hall through the small gate adjacent to the main gate with the permission of the concerned Hall Provost or Assistant Provost. She will have to write down her name, faculty, batch, roll no. and room no. in the gate-book placed in the Hall office.
 - (ii) If a student needs to stay overnight outside the Hall, she will have to apply in the prescribed form and to take permission of the Hall Provost or Assistant Provost. All such applications must be preserved up to the end to the session.
 - (iii) Each student must have a local guardian or contact person with a definite address in Chattogram. During admission the legal guardian will give consent in writing on the prescribed form where the address with contact number of the local guardian is mentioned. Legal or local guardian have to communicate with the Hall Provost and/or Assistant Provost from the contact number mentioned in the Hall admission form to take the permission of leave for the student from the Hall beyond University vacations.
 - (iv) Students have to entry their identification details including hours of departure and arrival in the gate-book before leaving and after coming back from each university vacation.

Those students who have no local guardian in Chittagong City, can assign their faculty Teacher/the Director of Students' Welfare of Hall House Tutor as local guardian. In this matter they will have to show the consent latter of the legal guardian.

- (v) Students will sign their specimen signatures in the reserved attendance book placed in the respective Hall every day. Provost and/or Assistant Provost(s) will take the attendance of the students in their respective Hall at least 3 days in a week from 9p.m. to 10 p.m.
- 4. The following categories of persons may be allowed to visit a female student at the Hall(s). The visiting hours shall be notified by the Provost and visitors shall not be allowed into the Hall outside visiting hours, except in exceptional cases: -
 - (a) The local guardian or his/her representative with a written authority from him.
 - (b) Father, mother, brothers, sisters and husband.

The Provost of the Hall should obtain (a) a specimen signature of the local guardian and (b) a list showing the names of her father, mother, brothers, sisters and husband from each resident Female student, within 15 days of her admission into the Hall. The list should be countersigned by the father or guardian of the student concerned.

- 5. Any visitor must enter his/her name and relationship to the resident student visited in the Visitors' Book.
- 6. (i) Visitors, whose named are on the approved list, may be permitted to meet resident students on not more than two days in each week at such times as may be fixed by the Provost and notified on the Notice Board of the Hall. Guardians shall not submit more than four names as regular visitors. In very exceptional circumstances, the Provost may permit a student to be interviewed by an approved of specially nominated visitor at any other time. All such permission shall be taken by the student in written form and the name of the visitor and hours of arrival and departure shall be noted in the Visitors' Book.
 - (ii) No male visitor shall be allowed to enter any room except the Visitors' Room. But female visitors with special permission of the Provost and/or Assistant Provost may be allowed to enter the Room.
 - (iii) No male student of CVASU shall be allowed to enter the Female Hall. If emergency, CVASU male students shall be allowed to Visitor's room of Female Hall with the permission of the Provost and/or Assistant Provost.
 - (iv) It is desirable that a local guardian should be a person with a family except enrolling student of CVASU. In case of any emergency her ward's infections, or other illness, she must be prepared to remove her ward from the Hall as soon as such notice is served on her or she will have to admit to the Medical Center of CVASU according to the advice of Medical Officer.
- 7. No resident student shall be permitted to visit any private house without the written consent of the legal guardian. Such permission may, only in urgent cases, be granted on the application of the local guardian to the Provost. Visits to members of the teaching staff in emergency' business are excluded from this rule.
 - With the permission of the Provost on the written application by the boarder, resident student will be allowed to go to early evening Cinema shows, family, social events, doctor appointment or university programs singly or in a group
- 8. Students shall not leave Chattogram during term time before they obtain leave of the Provost in writing. All applications for leave must be countersigned by, or supported by letters of, the legal guardian and only in exceptional case the local guardian, who shall state the nature of the escort arranged for the student.

Overstaying of leave is punishable unless extension is granted. Every application for extension of leave must reach the Provost at least one day before the expiry of the original leave. Every application for extension of leave on medical grounds must be accompanied by a certificate of are recognized Doctor and by a letter from the student's guardian.

- 9. Students are required to have their medical treatment from the University Medical Officer only. Any special medical treatment which may be taken by resident students apart from the prescribed one by the University Medical Officer, must be approved by him/her (Medical Officer).
- 10. Any breach of rules and regulation assigned by the Hall authority during admission of a new student will be considered as an offence and the Provost or Assistant Provost shall have the power to take disciplinary action his jurisdiction.

The Syndicate shall, on receipt of reports from the Provost concerned, withhold the publication of the results of candidates who do not comply with this Section.

The Proctorial Rules

- 1. The Proctor shall be an Officer of the University according to the provision laid down in Article 2 (Da) of the Chattogram Veterinary and Animal Sciences University (CVASU) Act, directly responsible to the Vice-Chancellor, and his/her rank would be that of a Provost of Hall. He would be assisted by Assistant Proctors who would be responsible to the Proctor and the rank of an Assistant Proctor would be that of an Assistant Provost of a Hall.
- 2. The following shall be the main duties of the Proctor/ Assistant Proctor(s) as per provision of the Article 21(2) of 1st Constitute of the Act of CVASU.
 - (i) He /She shall be responsible for the discipline and conduct of students within the University campus outside the Halls.
 - (ii) He/ She shall perform such other duties regarding discipline of students as may be required by the Vice-Chancellor from time to time.
- 3. (i) If CVASU built one or more outside campus one Assistant Proctor shall remain in each of the campus.
 - (ii) The Proctor, if he/she finds necessary, may recommend to the Vice-Chancellor the appointment of a Prefect of Prefects from amongst the senior students to help him/ her for maintaining discipline and order in the University.
- 4. (i) The Proctor shall take such steps as he/ she thinks necessary for the purpose of ensuring disciplined behavior and good conduct on the part of every student at all hours within the University Campus outside the Halls.
 - (ii) The students of the University will be provided by their respective Halls, with identity cards, which they must produce on demand by the Proctor or the Assistant Proctors.
- 5. (i) The Vice-Chancellor may delegate such of his/ her disciplinary powers as he/she may think fit to the Proctor/Assistant Proctor. The Vice-Chancellor shall issue standing orders as regards the extent of the power which he/ she delegates to the Proctor/ Assistant Proctor.
 - (ii) The Proctor shall have power to impose on a student a fine up Tk. 5000 (Taka five thousand) at a time for a breach of discipline or misconduct in the University outside the Halls. If he/ she is of opinion that a fine a fine Tk. 5000 is not sufficient he/she shall have power to expel a student from the University for a period not exceeding six months to be counted from the date of order. If, however, he is of opinion that the case requires

expulsion for more than 6 months he/ she shall refer the case to the Vice-Chancellor/ Students' Discipline Committee for such actions as he may deem fit. Any fine imposed by the Proctor on a student shall be reported to the Provost of the Hall to which the student belongs.

- (iii) The Assistant Proctor shall have powers to impose on a student a fine not exceeding Tk. 1000 (Taka one thousand) at a time, for breach of discipline or misconduct and report their action to the Proctor and to the Provosts concerned who will report such cases to the Vice-Chancellor.
- (iv) No clubs or societies or student's organization other than recognized Unions or Associations shall be allowed to be formed. No parties or entertainments shall be held within the premises of the University nor shall a student play musical instrument or use a loud speaker in the University premises during University hours without the previous permission of the Proctor. A breach of this rule will be treated as breach of discipline.
- (v) The Proctor may take suitable action against any student who willfully damages, disfigures or destroys University properties, or gardens, or does not observe the rules for facilitating movement within the University and for keeping the University neat and clean and for proper parking of cycles and vehicles.
- (vi) Each teacher of the University shall have proctorial powers and he/ she can when necessary take suitable action for maintaining discipline in the University. Every such action shall be reported to the Proctor.
- (vii) In an emergency, the Proctor or any of the Assistant Proctors can seek help of any employee of the University in the discharge of his/ her duties in the University or outside, at all hours and it shall be the duty of the employees concerned to give him/ her every reasonable assistance.
- 6. No student of the University individually or collectively shall declare a "strike" of the University students nor shall a student prevent another student of the University from attending the University classes, Laboratories, Library ,workshops, farms, food processing plant, Teaching Veterinary Hospitals (TVH), Physical health education section, institutes and IT lab etc.

A student found guilty of violation of the provisions of his Section will be liable to punishment up to expulsion from this University.

Student absenting themselves from their classes on the days of strike will be liable to forfeiture of their scholarships and stipends.

7. (a) No meetings of the students of the University other than the meetings organized by the University or by different Departments of the University or by the students Unions recognized by the University, shall be held in any part of the University without the

previous permission of the Proctor. No demonstration shall be organized within any part of the University campus without the previous permission of the Proctor.

- (b) Any demonstration, meeting and procession is strictly prohibited in the residential areas.
- (c) A student/group of students found guilty of violation of the provisions of this Section will be liable to punishment up to expulsion from the University.
- 8. If any student or group of students found guilty for ragging to any student or group of students, will be liable to disciplinary action according to the 5(b) of rules regarding general discipline.
- 9. If any student or group of students found guilty for the crime of sexual harassment and or eve-teasing will be liable to disciplinary action according to the 5(b) of rules regarding general discipline.
- 10. If any student or group of students found guilty for taking, carrying, preserving supplying and marketing of drugs (narcotics/ intoxicants) will be liable to disciplinary action according to the 5(b) of rules regarding general discipline.
- 11. If any student or group of students found guilty for bulling or cyber-crime(s) and or cyber bulling will be liable to disciplinary action according to the 5(b) of rules regarding general discipline.
